### How to make a submission

## How to write your submission

The Senate Economics Legislation Committee holding an extended inquiry on the <u>Currency</u> (<u>Restrictions on the Use of Cash</u>) <u>Bill 2019</u> and is taking submissions from the public. *Everybody* should make a submission. If you made a submission to the Treasury, send an updated version of that, citing any of the new information that has since come to light.

- Australia doesn't have a serious black economy problem, and <u>its black economy is actually</u> shrinking;
- <u>KPMG and its cronies are behind the real black economy</u>, which is multinationals avoiding tax and laundering money, not individuals and small businesses using cash;
- You should have the right to use cash for financial privacy, and to avoid bank charges and limit your exposure to bad banking practices;
- The IMF has revealed that the ulterior motive for cash restrictions is to trap people in banks so
  they can't escape extreme policies like negative interest rates; it will also expose bank
  depositors to <u>"bail-in"</u>—having their deposits confiscated to prop up the bank if it is in danger of
  failing.

The submissions deadline is 15 November, but don't delay—make your submission today! The reporting date is 7 February 2020.

If you do not want your submission published, write **CONFIDENTIAL** on the top of it in large letters.

#### When writing a submission there a few things to keep in mind:

- 1. **Submissions can be as long or short as you wish**. You can simply voice your opposition to the bill and outline the reasons why.
- 2. **Your voice is important.** Every submission is looked at by the committee (whether they decide to publish all of them online or not). Be sure to outline, not only what the issues are, but how you think problems can be addressed, as the committee looks to submissions for ideas to make recommendations.
- 3. **Make it personal**. Introduce yourself or/and the organisation you represent and include *why you are making the submission* and *why you oppose this Bill*. Be sure to keep it relevant and highlight your own perspective.
- 4. **Keep it relevant** to the bill. Whatever points you wish to make to the committee, be clear how they connect with your opposition to the bill.
